## Meeting Minutes

- Welcome and Introductions:** President Ranae Fehr welcomed everyone and called the meeting to order at 10:30 AM. Secretary Tom Stanuikynas followed with a Roll Call of counties. Quorum was not achieved.
- Agency / Partner Updates (NJTPA, OPA, NJDEP, NJAC, RPA etc.): Allen Weston, Legislative Director at the NJ Association of Counties** – Discussed Senate Bill S-3688, which promotes regional planning in an effort to control warehouse development. Allen appreciated the comments that the County Planners Association shared and is looking for more feedback as the bill progresses, specifically recommendations as to how oversight could work in the context of the bill. Allen also mentioned Senate Bill S-3397, which incorporates boardwalks into transportation local aid program and provides for Local Aid Infrastructure Fund grants to boardwalk projects.

**Executive Committee Report** – Ranae Fehr thanked everyone who attended last month's meeting with the SADC to discuss the draft Soil Protection Standards. The meeting was very productive.
  - Scholarship meeting last month – Kate Katzer offered a lot of good information based on her experiences in setting up and administering scholarships. The group is developing specific metrics and application package over the next couple months.
  - The CPA is hoping to put together a proposal for the upcoming NJAC conference in October. The Executive Committee is thinking of resurrecting the previous session focusing on the value that County planning provides, from a Commissioner's perspective. The proposal suggests panelists from four counties and a planner and a commissioner from each. If interested reach out to Ranae. Proposals are due May 28<sup>th</sup>.
